WHAT IS SAFE HARBOUR PROTECTION?

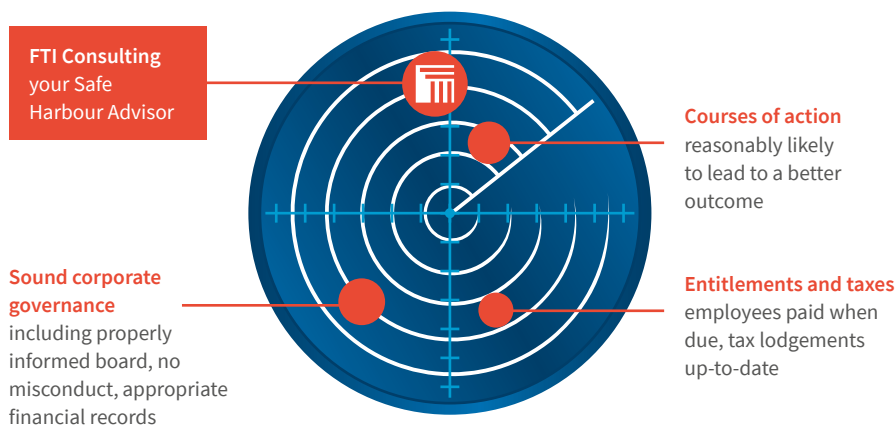
The safe harbour provisions of Section 588GA of the Corporations Act 2001 are there to provide directors and officers with the 'breathing space' to restructure businesses outside of formal insolvency, providing protection from insolvent trading liabilities should the restructuring be unsuccessful.

HOW DO I ACCESS SAFE HARBOUR?

Central to accessing safe harbour protection is that directors and officers develop "one or more courses of action that are reasonably likely to lead to a better outcome for the company" – compared to the alternatives of immediate voluntary administration or liquidation.
