Recent food recalls across Asia

2 June 2023 – honey dates

The Singapore Food Agency (SFA) has detected sulphur dioxide, an allergen, in honey dates at levels exceeding the maximum limit stated in the Singapore Food Regulations. The allergen was not declared on the food packaging. Excessive levels of sulphite in food could result in allergic reactions in individuals who are hypersensitive to sulphite. Symptoms include hives, itchiness, stomach ache, diarrhoea and vomiting.

9 June 2023 – Boston lobster

The Singapore Food Agency (SFA) has detected the presence of cadmium in Boston lobster, at levels exceeding the maximum limit for cadmium stated in Singapore's Food Regulations.

30 June 2023 – vegetarian mutton rendang curry

The Singapore Food Agency (SFA) has detected gluten in vegetarian mutton rendang curry and vegetarian golden roast duck, which was not declared on the food packaging labels.

11 July 2023 – crispbread

The European Commission Food Alerts' Rapid Alert System for Food and Feed (RASFF) issued a notification on the recall of crispbread due to exceeding levels of tropane alkaloids (atropine and scopolamine). The consumption of food containing tropane alkaloids may cause short-term effects including increased respiratory and cardiac rates, dilated pupils, mouth dryness, diarrhoea, and confusion.

13 July 2023 – prepackaged chilled crayfish

Prepackaged chilled crayfish was suspected to be contaminated with *Listeria monocytogenes*. The Centre for Food Safety (CFS) has informed the vendor concerned of the irregularity and has instructed it to stop sale and to remove from shelves the affected batch of the product. Should there be sufficient evidence, prosecution will be instituted. The distributor concerned has initiated a recall of the affected batch of the product according to the CFS' instruction.

21 July 2023 – coconut water drink

The product did not indicate the best before date according to the requirements stipulated in Food and Drugs (Composition and Labelling) Regulations.

8 August 2023 – eggs

The Singapore Food Agency (SFA) has detected the presence of *Salmonella enteritidis* (SE) in eggs imported from Ukraine. SE can survive in raw and undercooked eggs and may cause foodborne illness. The symptoms include diarrhoea, abdominal pain, fever, nausea and vomiting. SE can cause serious infection in vulnerable population such as the elderly, young children and those with weakened immune systems.

19 August 2023 – peanut butter cups

The Food Standards Australia New Zealand (FSANZ) has issued a notification on the recall of peanut butter cups milk chocolate and peanut butter cups white chocolate due to undeclared gluten allergen.

23 August 2023 – wheat free oats

The Food Standards Australia New Zealand (FSANZ) has issued a notification on the recall of organic wheat free quick oats from Finland which contained undeclared allergen (gluten).

30 August 2023 – oatmeal shake

Salmonella was found in a sample of imported prepackaged meal replacement product. The Centre for Food Safety (CFS) has informed the online vendor and distributor concerned of the unsatisfactory test result. The concerned vendor has stopped sales and removed the affected product from shelves. The concerned distributor has initiated a recall according to the CFS's instructions.



Recent food recalls across Asia

22 September 2023 – pepper chicken patties

The Singapore Food Agency (SFA) has detected egg in chicken patties, which was not declared on the food packaging label. Allergen in food could result in allergic reaction in individuals who are sensitive to it. Under the Singapore Food Regulations, food products containing ingredients that are known to cause hypersensitivity must be declared on food packaging labels to protect consumers with food allergies.

26 September 2023 – prepackaged cheese sauce

The Centre for Food Safety (CFS) received a notification from the RASFF of the European Commission that two batches of prepackaged cheese sauce product might have been contaminated with *Bacillus cereus* and are being recalled. The importer has stopped sales, has removed the affected product from shelves and has initiated a recall according to the instructions of the CFS. The CFS will also mark and seal the product ordered by the importer upon its arrival to Hong Kong and ensure that the product will not enter the local market.

28 September 2023 – organic mee suar noodles

The Singapore Food Agency (SFA) has detected gluten in organic mee suar, which was not declared on the food packaging labels.

28 September 2023 – Malaysian mooncakes

High levels of bacteria have been detected in two brands of Malaysian mooncakes that could potentially lead to food poisoning. The agency has directed the respective importers to recall the products.

11 October 2023 – camembert cheese

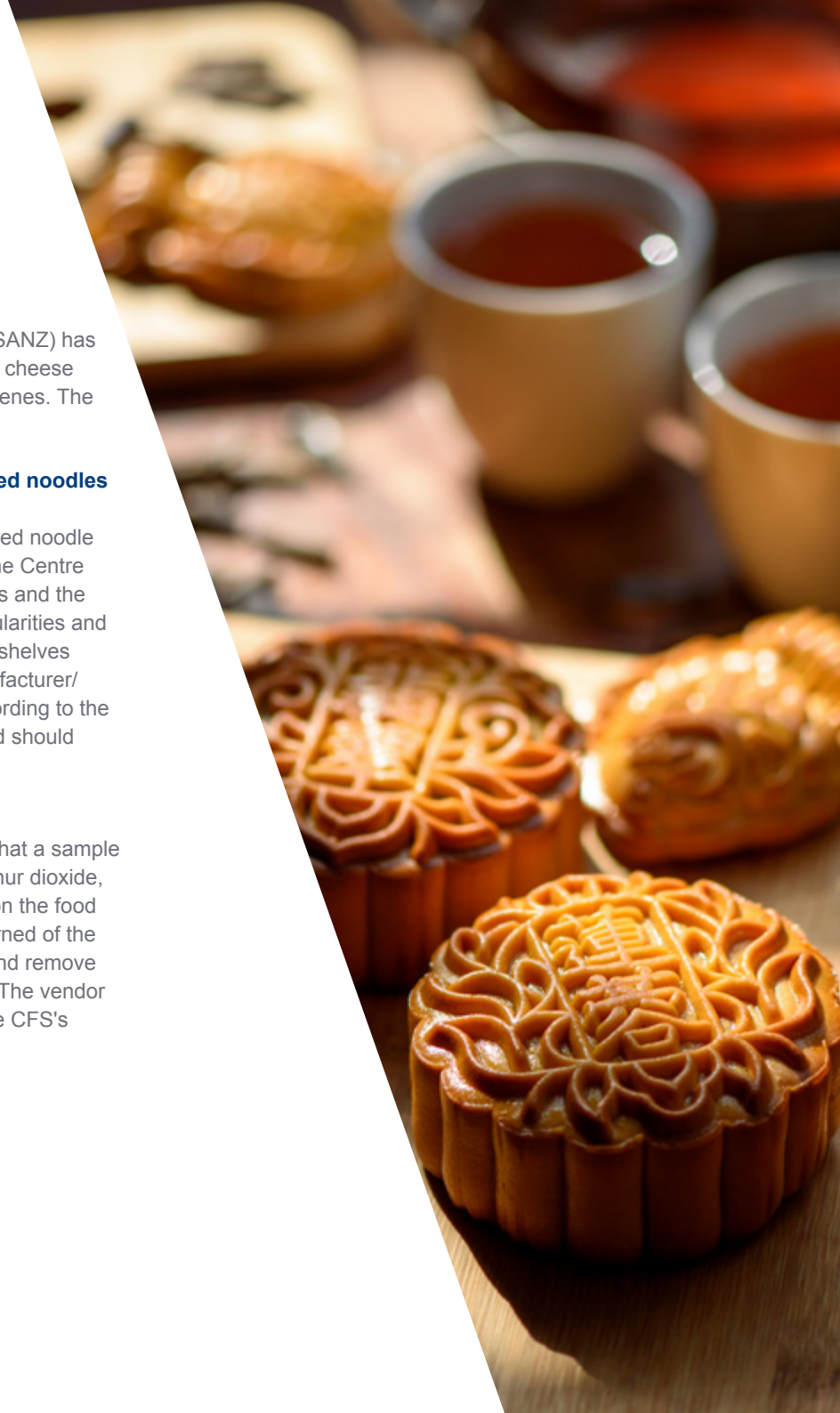
The Food Standards Australia New Zealand (FSANZ) has issued a notification on the recall of camembert cheese due to possible presence of *Listeria monocytogenes*. The recall is ongoing."

16 October 2023 – prepackaged egg-flavoured noodles and scallop-flavoured noodles

Prepackaged egg-flavoured and scallop-flavoured noodle samples were detected with sulphur dioxide. The Centre for Food Safety (CFS) has informed the vendors and the manufacturer/distributor concerned of the irregularities and instructed them to stop sales and remove from shelves the affected batches of the products. The manufacturer/distributor concerned have initiated recalls according to the CFS's instructions. Prosecution will be instituted should there be sufficient evidence."

24 November 2023 – bottled chili sauce

The Centre for Food Safety (CFS) announced that a sample of bottled chili sauce was found to contain sulphur dioxide, but the name of the additive was not declared on the food label. The CFS has informed the vendor concerned of the irregularities and instructed them to stop sale and remove from shelves the affected batch of the product. The vendor concerned has initiated a recall according to the CFS's instructions.
